The new passport options system is kicking off around the 1 December 2016, designed specifically for workers new to the industry. There is also a new suite of courses available for passport renewal, that offers more choice, more variety and more flexibility, each designed to focus on a specific area of health and safety. Soon to be followed by the launch of the online renewal modules in 2017.

The new Health and Safety Kit has replaced the old Safety by Steps and the Small Business Safety Plan. It's a pretty good system, it comes with all of the documents you need on-site and also is available electronically so the system can be adjusted to suit your needs. You can buy it as it is with a set of instructions and do it yourself for \$180.00, or you can buy extra time to go with it for an advisor to help set it out, so there are plenty of different options. It's really aimed at sites with 10-5 people or less which is the majority of our business. It's a step up from the previous system with plenty of room for people to change it and use it as they see better fits their business.

Site Safe have just written an Asbestos Awareness Course which will be available soon.
